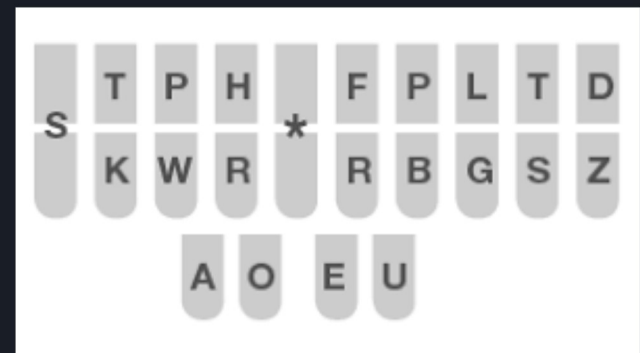

are State of Illinois employees who work under the Chief Judge of the Circuit in which they are employed. Official Court Reporters work in county courthouses and take a verbatim record of the words spoken in court by the use of machine shorthand.
